A BILL

To require inspection of all cargo on commercial trucks and
vessels entering the United States.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. MANDATORY INSPECTION OF CARGO.**

4 (a) MANDATORY INSPECTIONS.—No cargo trans-
5 ported by a commercial motor vehicle may enter the
6 United States from Canada or Mexico, and no cargo trans-

1 ported by vessel may be unloaded in the United States,
2 unless the Customs Service or other appropriate officer
3 or employee of the United States has inspected the cargo
4 to ensure that it complies with the laws of the United
5 States.

6 (b) DEFINITIONS.—In this section:

7 (1) CARGO.—The term “cargo” means prop-
8 erty, or mail, or both.

9 (2) COMMERCIAL MOTOR VEHICLE.—The term
10 “commercial motor vehicle” means a commercial
11 motor vehicle as defined in section 31101(1) of title
12 49, United States Code, that is used principally to
13 transport cargo.

14 (3) UNITED STATES; VESSEL.—The terms
15 “United States” and “vessel” have the meanings
16 given those terms in section 401 of the Tariff Act
17 of 1930 (19 U.S.C. 1401).

18 **SEC. 2. EFFECTIVE DATE.**

19 This Act shall take effect 6 months after the date
20 of the enactment of this Act.
