CRITICAL HARBORS OF REFUGE CRITERIA



Critical Harbors of refuge are a subset of Harbors of Refuge. Authorization or designation as a Harbor of Refuge does not automatically make a harbor critical.

Information used in the definition of Critical Harbors of Refuge:

- Presence of US Coast Guard Search & Rescue Station
- Presence of Commercial Fishing Fleet
- Distance to next nearest Harbor of Refuge

ALTERNATE FORMAT (SAME INFO)



(1) Category 1: Critical.

- (a) Presence of U.S. Coast Guard (USCG) Search & Rescue (S&R) Station and Commercial Fishing Fleet with nearest Harbor of Refuge located greater than 50 miles away, or
- (b) Nearest Harbor of Refuge is located greater than 100 miles away.

(2) Category 2: High.

(a) Presence of USCG S&R Station and Commercial Fishing Fleet with nearest Harbor of Refuge located greater than 35 but less than or equal to 50 miles away.

(3) Category 3: Medium.

- (a) Presence of USCG S&R Station, or
- (b) Presence of Commercial Fishing Fleet and nearest Harbor of Refuge located greater than 35 but less than or equal to 100 miles away.

(4) Category 4: Low.

- (a) Presence of Commercial Fishing Fleet and nearest Harbor of Refuge located greater than 20 but less than or equal to 35 miles away, or
- (b) Nearest Harbor of Refuge is located greater than 50 but less than or equal to 100 miles away

(5) Category 5: Acknowledged.

(a) Nearest Harbor of Refuge is located less than 50 miles away.



HOW USED?



 Critical Harbors of Refuge category is one of multiple metrics considered during the budget ranking process. (e.g. other metrics: tonnage, national security requirement, fisheries landings, condition, etc.)

 Criticality of harbor needs are categorized based on the criteria presented, enterprise budget ranking criteria, and capability submissions.
