Founded in 1882, Matson is one of the leading U.S. carriers in the Pacific.

Matson provides a vital lifeline to the island economies of Hawaii, Guam and Micronesia and premium, expedited service from China to Southern California.

The Company's fleet of 17 ships includes containerships, combination container and roll-on/roll-off vessels and custom-designed barges.

Matson, Inc. announced on May 29, 2015 that it completed acquisition of Horizon Lines, Inc. which includes Horizon's Alaska operations. Separately Horizon completed the sale of its Hawaii trade lane assets and liabilities to The Pasha Group
